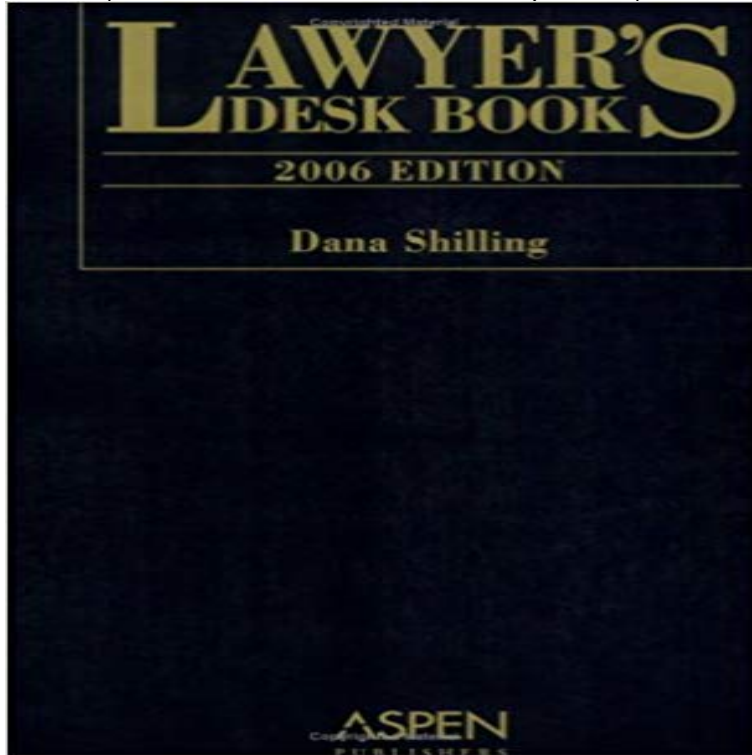

There is also new material on intellectual property law, on legislation stemming from corporate scandals, such as the Sarbanes-Oxley Act, and on legislation to cut individual and corporate tax rates, such as the Jobs and Growth Tax Relief Reconciliation Act. Chapters are in sections on areas including business planning and litigation, contract and property law, and law office issues.
