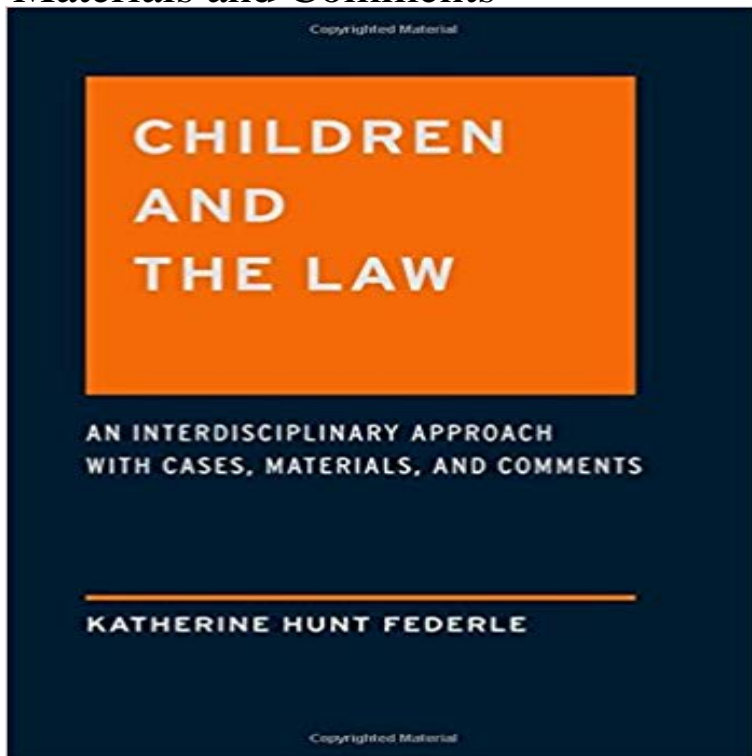


# Children and the Law: An Interdisciplinary Approach with Cases, Materials and Comments
