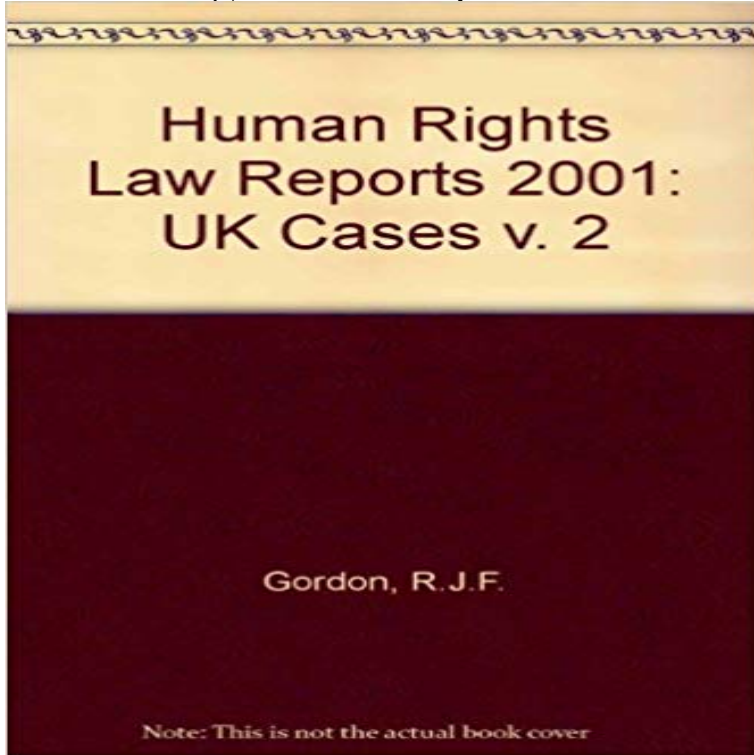


Human Rights Law Reports 2001: UK Cases Volume 2 (v. 2)
