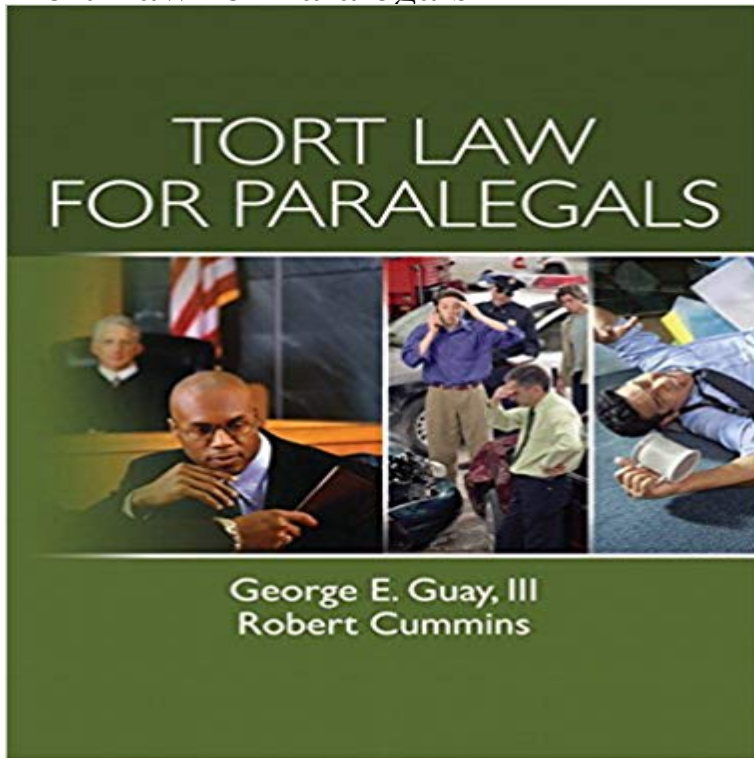


# Tort Law for Paralegals
