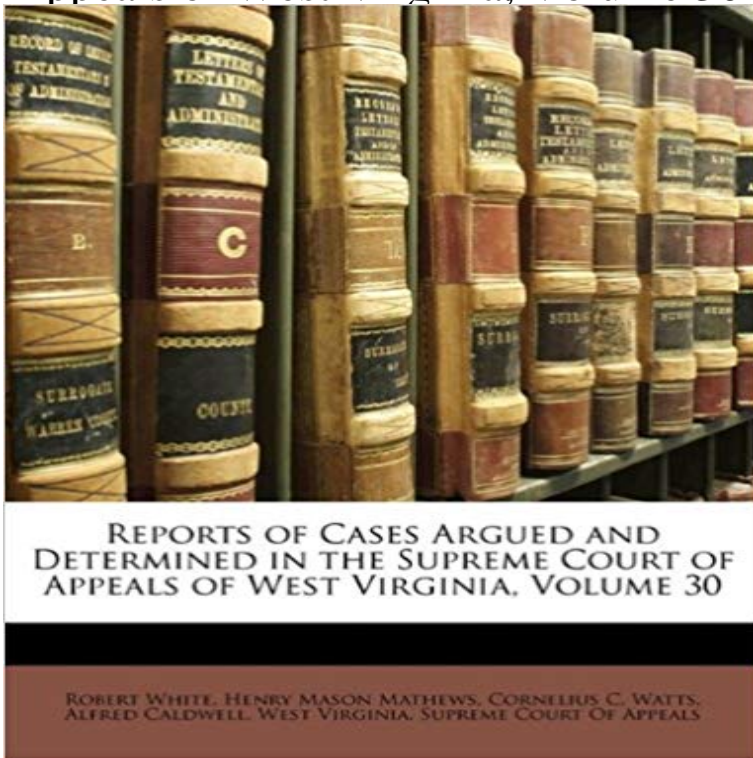


# Reports of Cases Argued and Determined in the Supreme Court of Appeals of West Virginia, Volume 30
